12 Special Resolutions proposed by the National Committee

SPECIAL RESOLUTION TO ALTER ARTICLES OF ASSOCIATION OF THE B.M.W. MOTORCYCLE CLUB LIMITED

Incorporated under the Companies Act 1985 with Registration Number: 4261129

THAT the articles of association of the company be altered as follows:

1. By inserting in Article 10 after the final sentence the words: "The Company may by ordinary resolution at a National Committee Meeting amend the format for annual subscriptions so that each individual subscription terminates at a date 1 year from its commencement so that by way of example a subscription commencing in April will terminate the following April."

The amended Memorandum and Articles of Association are already prepared, a copy of which has been initialled "BMW1" for the purpose of identification, and the secretary be directed immediately to register them with the Registrar of Companies.

Discussions both for and against the proposal were put forward.

In favour – 116

Against – 12

Abstentions – 12

The motion was carried with a 86.6% majority to allow the National Committee to amend the format for annual subscription to expire on the date 1 year after joining, existing members will be unaffected by this resolution.

That the Journal format be changed from A5 to A4 from January 2015

We have looked at the cost of changing to an A4 magazine and were surprised to find that printing *The Journal* as an A4 size rather than A5 would actually cost less:- the club would save about £1000 per year by having an A4 *Journal*. The A4 *Journal* would fall within the same weight and size band as the A5 *Journal* so there is no increase in postage costs. Stewart made up an A4 version of *The Journal* and having seen it, the national committee unanimously agreed that this was the way forward. The postal vote resulted in less than 20 % of the membership voting so apathy ruled and we stayed with the A5. This time it will be decided by a vote at the AGM and have your vote counted Yes or No it's up to you the member to decide. The A4 magazine will push the club forward into the future, with a bright, airy, more readable and visually attractive monthly magazine.

Discussions both for and against the proposal were put forward.

In favour – 115

Against – 10

Abstentions – 8

The was carried with a 86.5% majority to allow the Journal format to be changed from A5 to A4 from January 2015
